

# Creation of the Portuguese Entity for the Management of Authors' Rights

In Portugal, in particular in the press, the issue of copyright has been gradually worked out by the publishers, first in terms of regulation of contracts of employment with journalists. The Portuguese Press Association (API), representing almost all newspapers and magazines companies, both national and regional, has initiated a process of forming an entity to do the management of collective rights of these same companies, from 2007 on.

Following this process, API has established contacts with several European partners who were present at the formation assembly of PDLN, Press Database & Licensing Network, in November 2008 in Brussels.

The work started with the creation of a Portuguese entity; being a PDLN observer has gained particular relevance, benefitting from the experience of the European partners.



## The Formation of VISAPRESS


For this experiment, working visits made to NLA (UK) and INFOMEDIA (Denmark), as well as working sessions with PRESS BANKING (Belgium) were very important, and also the exchange of experiences with all other members of PDLN, since the beginning of 2009.

In September 2009, VISAPRESS was formally constituted as a cooperative for collective management of copyright and related rights of the publishers. Having been created by leading business media in Portugal, part of VISAPRESS are several national newspapers and magazines, as well the regional press, namely represented by API and also Christian newspapers and magazines, represented by their own association.

VISAPRESS comprises a total of 15 founding members, among them API, COFINA MEDIA, SGPS, S.A.; Controlinveste, SGPS, S.A.; Impala Editores, S.A. et al.

With the activity starting in the second quarter of 2010, it was very important for the VISAPRESS project to have the opportunity to learn from other members of PDLN, keeping in continuous contact with partners in other countries.

Shortly there will be carried out new working visits to partners, pursuing the identification of their business models and technological facilities in use.



## 2. PDLN Working Groups Update

- ► PDLN exists to encourage the development of publisher friendly international solutions for press cuttings and reviews. We have already seen technical connections allowing international content to be delivered emerging between PDLN members as a result.
- ▶ We discussed in Vienna the work being done to simplify building these connections, allowing PDLN members to offer international content more easily. We agreed we needed to develop a 'library' of standard commercial models and common technical standards, to be known as PDLN Connect.
- ► These PDLN Connect standard models would help one PDLN member connect its database services with another by offering common, fair and well understood contract models, database standards and the other building blocks.
- ► We hope this PDLN Connect initiative will reduce the amount of work needed to build these connections. For example, if we have a set of contract agreements (like IFFRO) a new contract should be quicker and cheaper, and if we adopt common meta-data identifying publications, reporting will be simpler and easier.


