# Leaked EC report supports ancillary rights.

A leaked draft EC impact assessment suggests radical changes to copyright are being recommended – much more than anticipated. The report – available at <a href="http://tinyurl.com/zgzyhzj">http://tinyurl.com/zgzyhzj</a> - suggests support for ancillary rights (compensation for news providers from search engines), support for a publishers right, but with a proposed exception for education copies 'for illustrative purposes' improved protection for authors, text and data mining and library preservation exceptions. It is a draft and any further progress after its publication in September is subject to a lengthy further negotiation. As such it is too soon to assume too much, but the sense is that news publishers have won the lobbying battle, with some minor setbacks on smaller issues, and there is no clear sense yet of how ancillary rights can work in practice. But the copyright wars are far from over.

# **CEDRO wins MMO court case**

CEDRO have announced that following several court applications they have reached an agreement with Augure (also known as Launchmetrics, and operating in several countries). Under this agreement:

- Augure agreed to pay for the past use of CEDRO licensed content
- Augure signed the CEDRO database license
- Augure accepted CEDRO tariffs for the use of digital newspapers.

As Augure supply other Spanish MMOs with web content, this will significantly increase the scope of web licensing in Spain. Patricia Riera Barsallo from CEDRO said "This case sets and important precedent for the rest of MMOs in Spain. The support of the courts for the CEDRO licence will help the wider moves towards copyright compliance and fair renumeration for content owners".
